UCU is assisted by various foundations and organizations throughout the world which are helping to find funding and develop this institution of higher learning.

The Ukrainian Catholic Education Foundation (UCEF) has been established in Canada and the United States to serve UCU. The Calgary Friends of UCU have been working with the University over the last three years.
